MINIMUM ADVERTISED PRICE ("MAP") POLICY SELECT SMARTPHONE AND TABLET ACCESSORY PRODUCTS SAMSUNG AUTHORIZED RESELLERS

Effective January 1, 2016

To maintain the value of the Samsung Brand and to properly position Samsung products in today's market, Samsung Electronics America, Inc. ("Samsung") is announcing a Minimum Advertised Price policy ("Policy") for select Samsung Smartphone and Tablet accessory products ("MAP Products")¹ This policy is intended to build upon Samsung's core commitment to excellence and to developing the best, highest quality products on the market, as exemplified by Samsung's significant investment in building a strong consumer following and establishing Samsung Mobile brand and product market value. Samsung's commitment to customer satisfaction is rooted in its innovation, quality, and progressive products, and the Samsung brand has become synonymous with world-class products, outstanding customer service, and product support. This policy applies to U.S. Authorized Resellers only.

In a unilateral policy decision concerning the marketing and sale of its products, Samsung has determined that MAP Products should not be advertised at a price less than the MAP price as designated by Samsung² (referred to herein as the "MAP Price") in Exhibit A. The Policy applies to all advertisements of MAP Products aimed at the general public in any and all media, including, without limitation, inserts, newspapers, magazines, catalog, mail-order catalogs, public signage, other print media, television, radio, e-mail, internet websites, e-commerce, flyers, posters, coupons, brochures, any method which uses the hypertext transfer protocol (http) or any internal link to a web based shopping cart, and other electronic media (collectively, the "Advertisements"). The price of MAP Products included in any Advertisement shall be the Advertised Price.

This policy in no way limits the Authorized Reseller from setting advertised or retail prices. Each Authorized Reseller remains free to independently establish its own retail prices and advertised pricing.

This policy applies to all U.S. Authorized Resellers and to all MAP Products. Advertisements that do not comply with Samsung's MAP Policy will be considered in violation and, without assuming any liability, Samsung will issue written notification of the failure to follow the Policy and execute the Schedule of Consequences as set forth below. Samsung reserves the right to revise any terms of the Policy at any time and in its sole discretion. This Policy document is provided for information and reference only. It is not incorporated into Authorized Reseller's Authorized Reseller Agreement by reference. The terms of this Policy are confidential and may not be disclosed to other parties.

I. MAP GUIDELINES

This Policy applies to all MAP Products, as set forth in Exhibit A. Please note that, in the future, any additional MAP Products will be added by submission of a Bulletin Addendum to Exhibit A.

- 1. Authorized Resellers cannot publish any price in violation of the aforementioned Policy either online or offline at any publication including those of any third-party. Third-party includes retailers, price comparison websites, search engines, auction websites, distributors, or any company conducting commerce. Violations will be subject to the Schedule of Consequences as outlined below.
- 2. Any violation by an Authorized Reseller is the responsibility of that Authorized Reseller only.
- 3. A "click for price", "mouse over for price", "see price in-cart", "add to-cart for lowest price" button, or any other method on a website intended to solicit potential customers to put the product in a cart that ultimately displays a price lower than the MAP Guidelines is a violation of this Policy.

- 4. All advertisements of MAP Products reflecting an Advertised Price must show the MSRP. Savings amount may be omitted, if desired.
- 5. At Authorized Reseller's option, the advertised price may be netted down to show the final price (in addition to showing the MSRP).
- 6. Free shipping and/or handling or free financing promotions do not violate this Policy.
- 7. Bundle promotions created by an Authorized Reseller that advertise specific Samsung items, and which are not sponsored by Samsung, shall meet the following guidelines:

If an Authorized Reseller advertises a bundle of products, which includes MAP Products, the Authorized Reseller must advertise the price or value of the MAP Products at or above MAP.

- 8. Importantly, this Policy does not apply to advertisements that simply announce discounts, rebates, coupons, and other promotions without including an Advertised Price for a specified MAP Product or Products. An advertisement only violates the Policy when (1) an Advertised Price for one or more MAP Products is specified in the advertisement and (2) the value of the discount, rebate, coupon, or other promotion results in a netted-down price that is below the MAP Price for that product or products.
- 9. The Policy does not in any way limit the ability of any Authorized Reseller to advertise that "they have the lowest prices", that they "will meet or beat any competitors price", that prices are "too low to show", or that consumers should "call or e-mail for a price", provided the Advertised Price is not less than MAP.
- 10. The Policy does not in any way limit the ability of Authorized Resellers to advertise any Samsung sponsored national rebate offer, when applicable, and to offer that rebate in addition to any discount offered as part of the MAP Price.
- 11. The Policy shall not apply to the final "Checkout" stage for online purchases, provided that:
 - The consumer has acted in a deliberate manner to "go to Checkout" or "make purchase payment," by clicking on buttons designed for such purpose;
 - The consumer's personal information is required, most commonly name and address, or login information that is inclusive of this personal information; and
 - Security measures are in place where all data is encrypted for security against fraudulent activity and product price is not accessible by price comparison engines or "spiders."
- 12. Promotional codes or coupons may be entered only at the "Checkout" stage. The manner in which an Authorized Reseller communicates the existence of such coupons or additional discounts is subject to the Policy.
- 13. At its own discretion, Samsung may, from time to time, allow Authorized Resellers to advertise specified MAP products below MAP, such as during a defined promotional period. In that event, Samsung will notify Authorized Resellers through an authorization letter, issued in writing, via email, or through such additional means as designated by Samsung under the terms of this MAP Policy, defining the promotional period and any applicable terms and conditions.
- 14. Samsung reserves the right to revise this MAP Policy or its list of MAP products and price list at any time and in any respect. When and if it does, those revisions will be provided to Authorized Resellers in writing, via email, or through such additional means as designated by Samsung under the terms of this MAP Policy.

- 15. <u>Unilateral Policy.</u> Samsung has adopted this Policy unilaterally in furtherance of its independent business strategy and reserves, at its sole discretion, the right to change this Policy and to interpret, enforce and otherwise handle all questions and issues related to the Policy. Authorized Resellers are free to determine on their own the prices at which they will advertise Samsung products. Nothing in Samsung's MAP Policy or Price List is to be construed as an agreement between Samsung and any Authorized Reseller on the resale price of Samsung products. Samsung does not seek and will not accept any such agreement. To be eligible for uninterrupted and continuous supply of Samsung products, Authorized Resellers must be in compliance with Samsung's MAP Policy. If any Authorized Reseller believes that any person associated with Samsung has attempted to depart from this Policy by attempting to agree or agreeing on a price at which the Authorized Reseller will advertise, quote, or sell a Samsung product, then the Authorized Reseller should immediately notify Samsung in writing at the address provided below in Paragraph 18. Interpretation and application of this Policy shall be made exclusively by Samsung in its sole discretion, and Samsung alone is responsible for enforcing its MAP policy when it determines that the Policy has been violated.
- 16. Samsung has unilaterally implemented this MAP Policy in accordance with its right to choose the Authorized Resellers with whom it wishes to deal. Samsung is not asking or requiring Authorized Resellers to agree to any aspect of this MAP Policy. Samsung is implementing the MAP Policy as its own policy and advising Authorized Resellers that there will be certain consequences if they advertise Samsung products at prices less than the applicable designated MAP Price. Importantly, Authorized Resellers remain free to determine if they wish to follow the Samsung MAP Policy or not.
- 17. The details of Samsung's enforcement decisions will be strictly between the Authorized Reseller that has violated the MAP Policy and Samsung. Samsung salespeople are not allowed to discuss those details with other Authorized Resellers, and they cannot modify the Policy's provisions.
- 18. If you have questions regarding Samsung's MAP Policy, all communications should be directed to Samsung's Minimum Advertised Price Policy Administrator by e-mail at mappadministrator@sea.samsung.com or in writing at the following address for verification:

- 19. Authorized Resellers will be notified in writing or by e-mail if they have violated the MAP Policy. Samsung will consider each violation based on its own facts, and any decision by Samsung to impose a penalty pursuant to this Policy cannot be appealed. Samsung may, however, unilaterally decide to review an Authorized Reseller's status after an independently determined period of time.
- 20. This MAP Policy is effective immediately and will remain in effect until further written notice from Samsung's MAP Administrator. Samsung reserves the right to terminate or amend this Policy in its sole discretion at any time without prior notice. This MAP Policy supersedes any and all prior policies established by Samsung on the same subjects.

II. SCHEDULE OF CONSEQUENCES FOR VIOLATING MAP POLICY

General

- Counting of Violations applies once for each Advertisement Vehicle containing a Violation, regardless of whether that Advertisement contains more than one Violation. For example, if two Smartphone or handset accessory models on one circular advertisement are found to be in Violation, that would constitute as one Violation. For online advertising, each day of Violation would constitute as one Violation. For example, if two Tablet accessory models listed online are found to be in Violation in one calendar day; that would constitute as one Violation.
- If an Authorized Reseller is under Violation, as set forth in the table below, but does not satisfy the complete terms of the corresponding Consequence specified in this Policy, such would count towards a new instance of Violation.
- Samsung shall, at its sole discretion, determine the MAP Product among the MAP Products that
 have been in non-compliance of this Policy, for which the Consequence of Violation applies. For
 example, First Violation was on MAP Product "A" and Second Violation was on MAP Product "B".
 Samsung shall have the discretion to choose whether MAP Product "A" or "B" cannot be listed in
 Advertisements for the designated period of time.
- At the end of each calendar year, effective midnight on the 31^{st of} December of that year, all Violations are dismissed such that Authorized Reseller shall have no Violations.
- The Violation schedule applies to each of the MAP Products.
- In addition to the specific Consequences outlined in the tables below, without assuming any liability, Samsung may:
 - a. In the event of printing error, require an immediate, formal retraction on all offending Advertisements (such retraction must be issued no later than one week after the error).
 - b. After the fourth violation, Samsung, at its sole discretion, may buy back any remaining sellable inventory of a MAP Product (as determined by Samsung according to the guideline above) of the Authorized Reseller via one of its Distributors.
 - c. Terminate the Authorized Reseller Agreement.

Violation on Print and Online Advertising

Violation	Consequence
First Violation	Warning
Second Violation	Cannot list MAP Product online or in any Advertisements for 6 weeks
Third Violation	Loss of ability to purchase MAP Product for the life of that Product AND cannot list that MAP Product online or in any Advertisements for the life of that Product.
Fourth Violation	Loss of ability to purchase all MAP Products for the life of all MAP Products AND cannot list any MAP Product online or in any Advertisements for the life of all MAP Products.
